### **Housing**

- **Have you just received an eviction notice?**
- **Are you having problems with your apartment or rental home?**
- **Is your house in foreclosure?**
- **Do you need housing assistance or public housing?**

### **Consumer**

- **Are you having trouble paying your credit card or other debts?**
- **Are you considering bankruptcy?**
- **Have you been sued or has a creditor garnished your income or attached valuable property?**
- **Did you get ripped off by a car dealer or door-to-door salesman?**
- **Are debt collectors harassing you?**
- **Do you think your identity has been used by someone else?**

- **Have you noticed mysterious debts or unknown accounts on your credit report?**

### **Health Care/Public Benefits**

- **Do you need food stamps or cash assistance?**
- **Have you been denied benefits from Nevada State Welfare or Social Security?**
- **Do you have questions regarding Medicaid or Medicare?**
- **Are you considering nursing home care and wondering how to pay for it?**
- **Have you been denied unemployment benefits?**

### **Estate Planning/Wills**

- **Do you have questions about what will happen to your property after death?**
- **Do you need help creating a will or trust to avoid probate?**
- **Do you want to have someone make health care decisions for you if you are incapacitated?**

### **Guardianships/Visitation Rights**

- **Do you want to gain custody or visitation rights over grandchildren?**
- **Do you need a guardianship over a loved-one?**
- **Do you want to adopt a child or act as a foster parent?**
